We refer to your planning consultation relating to the above site, and we can provide the following comments in respect to the proposed development.

We have reviewed the amended details submitted as part of this application with particular focus on drawing number 1715/18 Revision F

We note that surface water will continue to drain to a soakaway and foul water will communicate to the public sewer. In principle this proposal is acceptable however in order to achieve the desired housing layout an existing public sewer will need to be diverted. We welcome the applicant to contact us direct to discuss this proposal and to progress with the necessary applications.

In light of the fact that further work will be required and a technical assessment of the public sewer diversion, we request that if you are minded to grant planning permission that the following <u>Conditions</u> <u>and Advisory Notes</u> are included within any subsequent consent.

Conditions

No development shall commence until a drainage scheme for the site has been submitted to and approved in writing by the Local Planning Authority. The scheme shall demonstrate how the site will be effectively drained; the means of disposal of surface water, indicate how foul flows will communicate to the public sewerage system and demonstrate how the existing public sewer crossing the site will be

Reason: To prevent hydraulic overloading of the public sewerage system, to protect the health and safety of existing residents and ensure no pollution of or detriment to the environment.

Advisory Notes

The applicant may need to apply to Dwr Cymru / Welsh Water for any connection to the public sewer under S106 of the Water industry Act 1991. If the connection to the public sewer network is either via a lateral drain (i.e. a drain which extends beyond the connecting property boundary) or via a new sewer (i.e. serves more than one property), it is now a mandatory requirement to first enter into a Section 104 Adoption Agreement (Water Industry Act 1991). The design of the sewers and lateral drains must also conform to the Welsh Ministers Standards for Gravity Foul Sewers and Lateral Drains, and conform with the publication "Sewers for Adoption"- 7th Edition.
