Yes, please confirm that you wish to **withdraw** the application as soon as possible once you have taken instruction from your client, please may you give an indication of how long this may take? I don't consider it feasible to amend the application to only include the applicants land within the application red line without fundamentally changing the application, which would not be accepted and so I would advise that the only recourse would be to withdraw the application and resubmit. However I would draw your attention to the fact the site is outside of any settlement, does not comply with RA3 and is significant conflict with the policies of the development plan.

Secondly, the application is currently considered to be **invalid** as the certificate accompanying the application is false and so the Local Planning Authority cannot entertain the application as per the statutory requirements of Section 65 & 327A of the Town and Country Planning Act 1990 (the act). As can clearly be seen from the below block plan as proposed and the extract of the title plan (for Auberrow House) which is not registered to your client. Only certificate A has been completed of the application form (submitted by "The Late Mr Davies Estate") and no notice has been served on the other land owner, the application is invalid. Should you wish to contend the above then please write to me and I will consider the matter, however I would draw your attention to paragraphs six & seven of section 65 of the act with the offence that is set out there in; this is after all the second time this reckless error has arisen (Cotts Lane being the other 190279).
