Replant with at least three native species, details to be decided, but probably sorbus commixta, betula jacquemontii and pinus sylvestris.

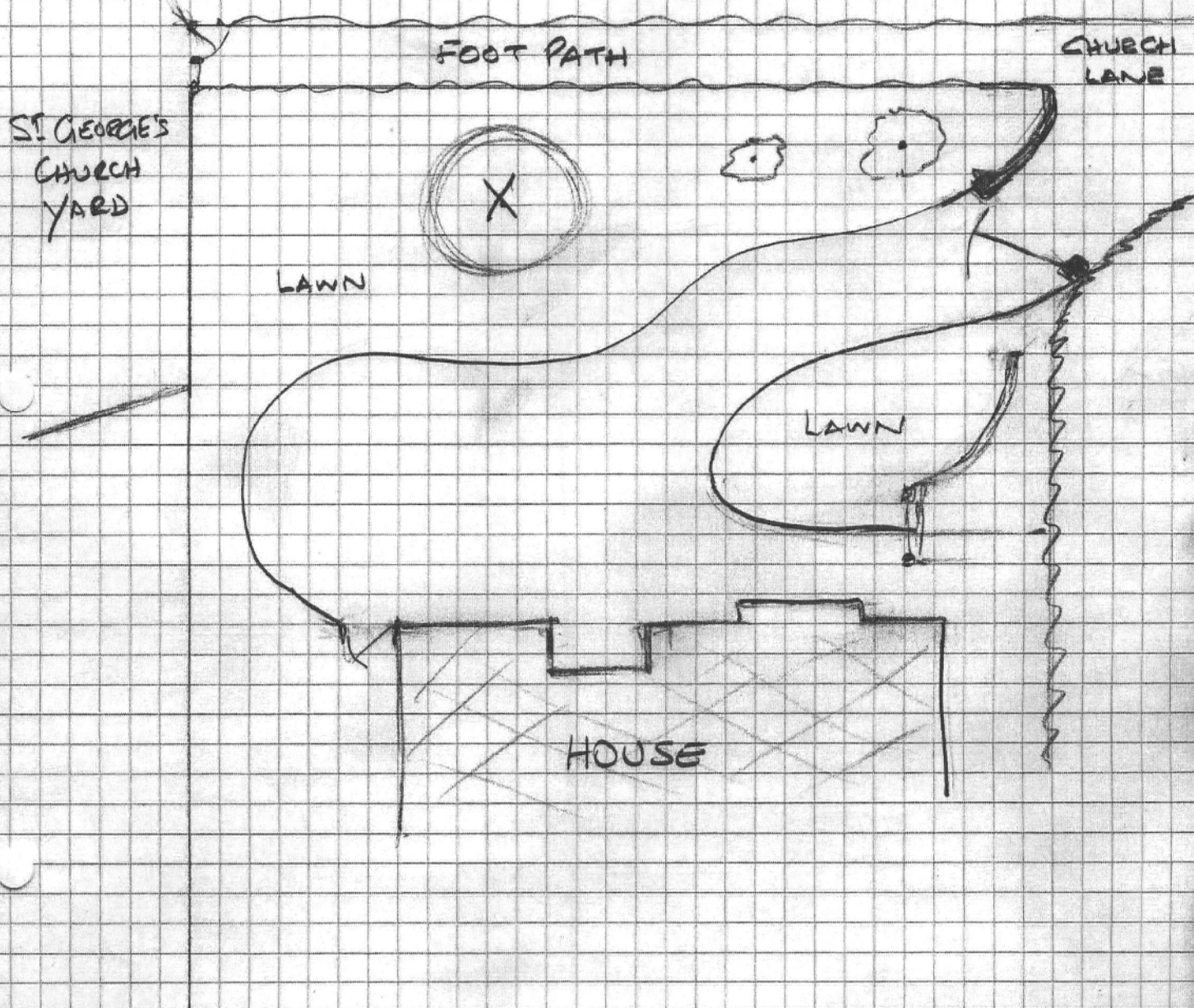
