In consideration of risks to human health from potential contamination, having reviewed the above report, I would make the following observations:

The Brownfield Solutions Report appears to be one of a series of reports at the site which have been submitted over the years. Prior to and during 2014 we forwarded some queries to the technical specialists and via the allocated Planning Officer. Given the passage of time and recognition that the site has been in use for a number of years it is perhaps most necessary to address those matters identified and outstanding from the most recent Brownfield Solutions Report in an appropriate context to ensure they have been satisfied.

To my mind, the most reasonable way to achieve this would be to ask that the applicant commission an appropriate specialist to review all that they have on file, take a look at the measures required by <u>all</u> of the reports (clean cover and vapour membrane is recommended by Brownfield Solutions, <u>others may not have been the same</u>) and ensure any uncertainties identified in the email and memo referred to have been addressed by way of letter report including verification documentation.

With this memorandum I have provided (below) the last email for which I cannot find a reply to both the Planning Officer and the Technical Specialist. I believe you will have a copy of the letter on file (Philippa Day, 2009).

In order to reasonably facilitate the supply of information perhaps the following amendment or variation of condition could be used to ensure what's required is provided.

1. A review of all contaminated land and site investigation technical reports associated with the development should be carried out by a suitably qualified person as described in the NPPF. The information within these should be used to prepare an interpretative report to collate and include all recommendations and conclusions of the reports. A validation and verification plan shall be included which will explain how each conclusion and recommendation has been or will be addressed so as to demonstrate that risk to human health and the wider environment has or will be mitigated. This shall be submitted and approved in writing by the Local Authority to be submitted within 3 months.

Reason – In the interests of Human Health.

2. Pursuant to (1) above, within 3 months of submission of element (1) suitable verification and/or validation to confirm all required works have been carried out in accordance with the agreed details shall be submitted to an approved in writing by the Local Authority.

Reason – In the interests of Human Health.

Depending on whether or not further works are required, elements 1 and 2 may be carried out concurrently. The conditions have been split in such a way so as to address those items for which suitable validation is readily available whilst allowing for unforeseen oversights or uncertainties.

Please note that consultations should be made with the Environment Agency with regard to controlled waters for which we have not provide any comments.

I would be grateful if the contents of this memorandum are passed to the applicant/agent for their attention.
