Details of the pre-application advice received

The principle of achieving annexed accommodation through the conversion of an existing outbuilding, in this case a barn of traditional construction, is supported by the development plan when read as a whole. This is notwithstanding the open countryside location of the site. A condition would likely be imposed to limit it to ancillary use and to provide clarity and control over any future subdivision. An application for planning permission and listed building consent will be required. The application could be in householder form (as opposed to 'full') provided that it can be demonstrated that the barn is in lawful incidental use to the main house and situated within its established curtilage. The requirement for a drainage report has been confirmed. This report should address PTP capacity to deal with additional flows, confirm that any existing drainage field is sized accordingly and calculate whether resultant discharge flows would remain under a total of 2m3/day.
