T1. Norway Maple 'Crimson King' (Acer platanoides purpurea). This clients are fond of the tree and have had it maintained regularly as it grows very close to the house and overhangs the green house. They request a 25% crown reduction back to the previous points to keep it at a suitable size for its location.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
