Further to our email(s) I have now taken instruction from the client.

For the drive they would like to use "mid grey block paving", there reasoning is given below.

From Mr and Mrs Miles:

With regard to the driveway, we'd like to have a distinct visual definition between the road and the entrance to the property so would not choose to use tarmac. Having looked more closely at resin bound gravel, we've found that it isn't recommended for drives where cars would need to frequently turn around (as in the case of ours) as the gravel is likely to become loose with the movement of the tyres. Therefore, we feel the best option would be to use driveway block paving in a mid grey colourway - this would give visual definition and a sense of arrival to the property, whilst being a practical and hardwearing surface treatment that will also provide a link with the materials used on the house.

I await your further advise on the matter. If you need anything further from me please let me know, thank you for your assistance.

I have suggested the material used is harmonious across the small development, although Thirty Acres has a wide palette used in current property. It would be my preference that the same material is used, as whilst the properties are individual there should be some link in my opinion.

From the original reserved matters 150981, these were discharged with the specification "...Permeable Tarmacadam driveway retained by edging stone..." Whilst this is rather loose, it is the intention that this is a traditional dark grey surface with edging stone to compliment the natural local stone detailing on the building from plot 1.
