With regards to the above, please can the following be considered:

- At the south elevation of the dwelling, please could rethink window detailing of the conservatory which looks quite awkward, you may want to consider continuing extending the glazing all the way along that south elevation;
- The two ground floor windows at the south elevation of the dwelling should be in proportion with one another;
- At the south elevation of the garage, please kindly shade in the board material which doesn't appear to be evident and gives the impression that the building is open on two sides;
- Would you kindly specifically advise all walling and roof materials for both the dwelling and garage this can be shown on the proposed plans or email return;
- Please complete climate change and biodiversity checklists and send through to me, which was identified on the acknowledgement letter sent through to you on 16 December 2020.
