PLANNING OFFICER'S APPRAISAL:

Site description and proposal:

The building is located on the southern side of High Street within the heart of Hereford City Centre.

The application seeks consent to allow for a fascia sign and one projecting sign.

Cllr Tawn – confirmed via email received on 28 September 2017 that the application could be determined under delegated powers.

Hereford City Council – no response.

Transportation – Proposal acceptable (no conditions and / or informatives required).

Historic Buildings Officer – The submitted proposal is acceptable; it is considered the new signage design will have a neutral impact on the Conservation Area.

CCTV - No issues with this application.

Historic England – No Comment.

Constraints:

Grade II* Listed Building (adjacent), Conservation Area, SSSI Impact Zone, Area of Archaeological Importance and Art. 4.

Appraisal:

The application seeks advertisement consent to allow for a number of new signs to be erected at the property. Consent is sought to allow the proposals to be retained until the 13 September 2022.

Paragraph 67 states that poorly placed advertisement can have a negative impact on the appearance of a building and natural environment. It confirms also that advertisements should be subject to control only in the interests of amenity and public safety, taking account of cumulative impacts.

Policy LD1 states proposals should demonstrate that character of the landscape and townscape have positively influenced the design, scale, nature and site selection, protection and enhancement of the setting of settlements and designated areas.

Policy SD1 states proposals should create safe, sustainable, well integrated environments for all members of the community.

The proposed signage including the projecting sign will not cause an adverse impact upon the surrounding environment. The proposed signage will use a colour scheme that complements the building and the surrounding landscape and will not cause an adverse impact upon the surrounding landscape, designated historic assets, townscape or highway safety.

The proposal complies with the adopted Development Plan and is therefore recommended for approval.
