Hi Ollie

We have got to the bottom of this. The original application red line included highway land to the north as we had proposed an access roundabout to link into the Hardwick Bank site. This red line was 4.95ha. I assume the reference to 4.85ha in the planning statement is a typo I'm afraid.

Following discussions with highways we amended the access plans and therefore didn't need to include all the land to the north, thus there was an amendment to the red line to reduce this to 4.73ha, which is the correct site area.

The two plans that we submitted post validation, outlined below, are therefore the correct plans to be referencing moving forward. The nutrient budget therefore reflects the correct site area of 4.73ha.

Illustrative Framework Plan – A17050 006E Location Plan – 07050.001A I have attached both these plans for ease of reference.

I hope this clarifies matters, but if you have any other queries, please do let me know.

We should be able to issue you with a Shadow HRA early next week. Once we have had feedback from Natural England on this will you be in a position to approach the Councillor Davies to discuss the application?
