The educational facilities provided for this development site are North Hereford Early Years, Trinity Primary School, Stretton Sugwas Primary School, St Francis Xavier's RC Primary School, Whitecross High School, St Mary's RC High School and North Hereford Youth.

Trinity Primary School has a planned admission number of 90. As at the schools summer census 2022:-

• 2 year group's are at or over capacity- Y4=90, Y6=97

Stretton Sugwas Primary School has a planned admission number of 30. As at the schools summer census 2022:-

• 2 year groups are at or over capacity - YR=30, Y1=30

St Francis Xavier's Primary School has a planned admission number of 30. As at the schools summer census 2022:-

5 year groups are at or over capacity- Y1=30, Y3=32, Y4=31, Y5=31, Y6= 32

Whitecross Secondary School has a planned admission number of 189. As at the schools summer census 2022:-

• 2 year groups are at or over capacity- Y7=191, Y8= 193

St Mary's RC High School has a planned admission number of 150. As at the schools summer census 2022:-

3 year groups are at or over capacity- Y8=150, Y9= 150, Y10=150

Approximately 1% of the population are affected by special educational needs and as such the Children and Young People's Directorate will allocate a proportion of the monies for Primary, Secondary and Post 16 education to schools within the special educational needs sector.

Please note that the Planned Admission Number of the above year groups is based on permanent and temporary accommodation, whereas section 3.5.6 of the SPD states that the capacity should be based on the permanent accommodation, therefore, additional children may also prevent us from being able to remove temporary classrooms at Trinity Primary School that we would otherwise be able to do.

In accordance with the SPD the Children and Young Peoples Directorate would therefore be looking for a contribution to be made that would go towards the inclusion of all additional children generated by this development.
