


Four poultry units to house broilers. Each poultry unit would be 18.289 x 91.605m with an eaves height of 2.59m and a ridge height of 5.4m. There would be a control room attached to each unit measuring 3.05 x 4.57m. Three feed bins would be located between each pair of units. The feed bins would be 7.4m high. Ancillary infrastructure would include a generator shed and office (3.05 x 6.10m), a shower block (3.05 x 6.10m) and two sets of four gas tanks located on a concrete base, measuring 4.6 x 21.4m.

The ventilation system would consist of computer controlled high speed ridge-mounted fans to control temperature. The units would include a system for the provision of feed and water.
