Dear Roland

I have received this and your later email with the photograph.

The revised plan would place the building on the same level as the existing poultry sheds where the redundant incinerator was positioned. I attach a photograph of the incinerator site. The revised position would be in replacement of the incinerator. The revised location would be lower and therefore very little of the building would be visible above the existing bund to the south of the site.

I originally envisaged a shed colour to match the existing poultry house roofs (albeit bleached from its original colour). I think the best colour match would be a Merlin grey. I think Goosewing grey would too light and Slate too dark. I suspect the photograph you sent me was slate grey.

Please let me know what your thoughts are.

I would also be grateful if you would confirm the proposed colour of the external walls and roof with reference to BS and / or RAL colours?
