PHYTOPHTHORA, COPPING WILL PRODUCE VIGOROUS REGROWTH AND PROLONG THE LIFE OF THE TREES. BETWEEN 7-10 ALDER AND/OR WILLOW WILL BE COPPED AND/OR PLEACHED IN SECTION A TO B, AND BETWEEN 3-5 IN SECTION C TO D.

TREES PLEACHED WILL BE HINGED INTO THE RIVER AND SECURED TO THE RIVERBANK TO ENCOURAGE REGENERATION FROM THE BASE OF THE TREE AND IMPROVED RIVER HABITAT FOR FISH SPECIES.

WE PROPOSE POLLARDING A MATURE WILLOW TREE CLOSE TO POINT D ON THE MAP, TO PROVIDE FRESH GROWTH AND PROLONG THE LIFE OF THE TREE.

PROPOSED WORK HAS BEEN DISCUSSED WITH JAMES BISSET (19/12/16).

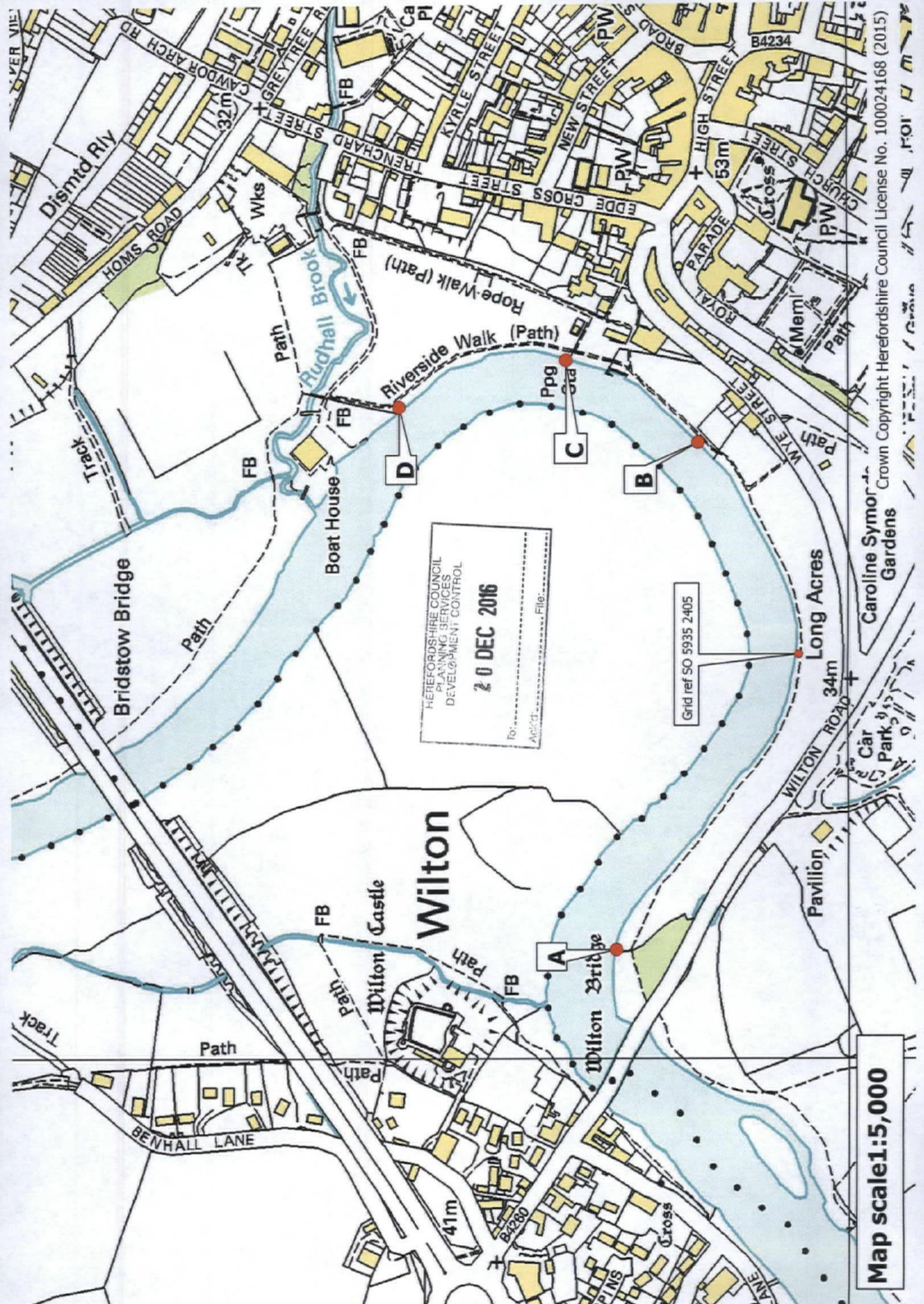
