T1. Tilia platyphyllos (Large-leaved Lime)- This tree is in good health but it is very large and its height far exceeds the distance between it and the house at 18 Admirals Close. The owner of this property is particularly concerned for the safety of his home, should the tree fall down. This concern was exacerbated during the recent very high winds where smaller, healthy trees came down, nearby. The client would like to reduce the upper canopy by 25% to reduce the likelihood of failure, whilst retaining an attractive form.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
