The conversion of the barn to a dwelling was completed in July 2012 and has been continuously occupied by Mr. and Mrs. Williams since July 2012. The variations to the original planning application 2005/1408/F are identified on the attached drawings and were made at the time of the conversion prior to the couple moving into the property. The time limit for any enforcement action has now passed making the development lawful in terms of planning.
