It seems likely that there may be some disruption to safe passage along either footpath during the construction work. this disruption is minimised or, if possible, care taken to safely divert the Association footpath(s) for а minimum time period, Herefordshire Ramblers has no objection to this proposal

# Appraisal:

The proposal is for the relatively minor upgrade of existing pole lines. The lines are not located in an area considered to be of a sensitive nature and the modest scale of the works is such that there is no significant adverse effect on the environment or material change to the existing situation that would so impact upon third parties or the immediate area. No adverse representations have been received from relevant consultees.
