Wall material:

STONE Plinth/skirt detailing is in natural stone, areas as per approved plans. Stone is recycled/reused from a building on the estate and believed to be of local origin. Image for guidance of laid wall. Sample provided.



TIMBER Sections of wall are clad in timber and there is timber detail around the building. Green Oak is proposed which will weather naturally to a silver grey. Boards are to be fixed horizontally as per approved drawings. Sample provided. Example image for guidance of fixed boards.



Marley Modern Interlocking tile in anthracite. Image of example for guidance and sample of tile supplied.


