I write to inform you that Gladman Developments Ltd has appealed to the Secretary of State against the refusal of Herefordshire Council to permit the development described above.

The reasons for the refusal were:

1 By virtue of the insufficient width of the proposed footway provision, taken together with the unsatisfactory nature and environment of the existing local highway network, the application fails to demonstrate that a safe and suitable means of pedestrian access can be provided to serve the development for all users including the needs of people with disabilities and reduced mobility, as well as minimising the scope for conflicts between pedestrians, cyclists and vehicles. The proposal is therefore contrary to Policy MT1 of the Herefordshire Local Plan - Core Strategy, as well as the principles as set out within Paragraphs 106, 110, 111 and 112 of the National Planning Policy Framework (2023).

2 In the absence of any dedicated cycle provision forming part of the access arrangements serving the proposed development, the application fails to demonstrate that the proposal would facilitate a genuine choice of modes of travel which includes cycling as an alternative to the private car and thus does not have regard to the location of the site and the need to promote sustainable travel choices. The proposal is therefore contrary to Policy MT1 of the Herefordshire Local Plan - Core Strategy, as well as the principles set out within Paragraph 106 of the National Planning Policy Framework (2023).

The Secretary of State has directed this appeal will be the subject of a Hearing will open on 13 August 2024 and will be held at Hereford Group Training Association, Holmer Road, Hereford, HR4 9SX.
