Dear Martin,

It's been brought to my attention that Lucknow Cottage has two drains served this property. One drain (Drain A) is located next to Lucknow Cottage, the other (Drain B) crosses the proposed development site, and is on the north-west corner of the Homestead, a neighbouring property. I understand your client had riparian responsibility for both drains. The sale of the cottage excluded a large section of the then garden. The proposed development is located in this section of land.

I understand, therefore, that your client has retained responsibility for Drain B (DB) which crosses the site of the proposed development. The new owners of Lucknow Cottage now have riparian responsibility for Drain A(DA) next to the cottage. This drain, at the bottom of a long slope therefore receives significant surface water following even light rain. It has been brought to my attention that that DA joins Drain B (DB) on the site of the proposed development and there is a need to confirm the precise location of DB. There has also been no mention of DA. In consequence, any plans for the relocation of DB must ensure that DA remains connected to DB.

I would be grateful if a response can be provided to this query and if so, an updated block plan.

Furthermore, just to let you know that the application has been requested to be re-directed to Planning Committee by the Local Member and I will be in touch to confirm should the application go that way.
