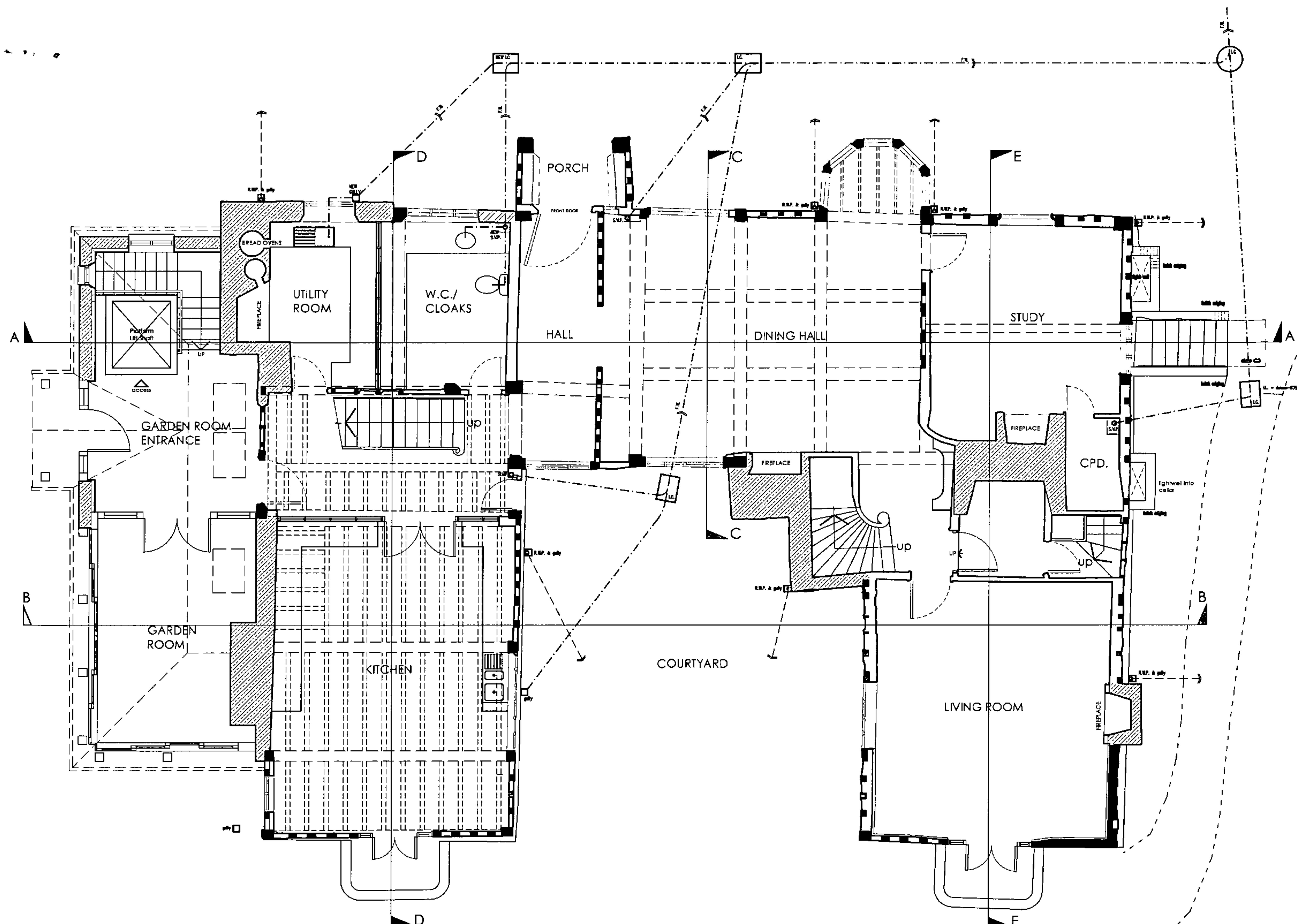

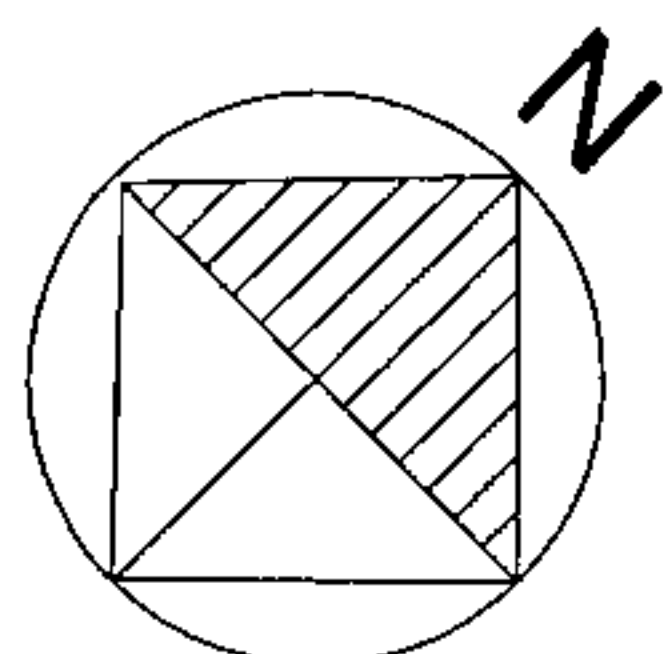

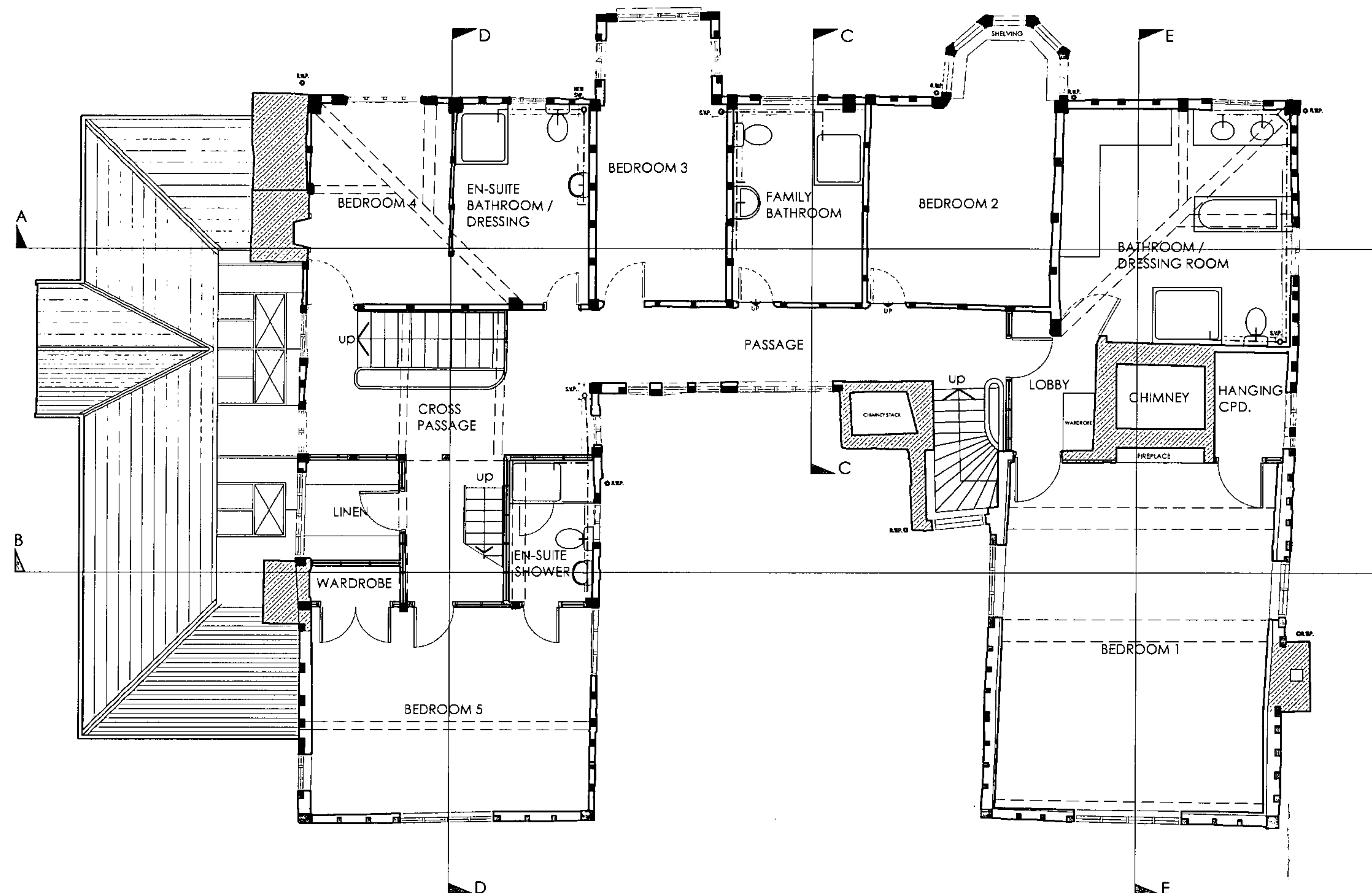

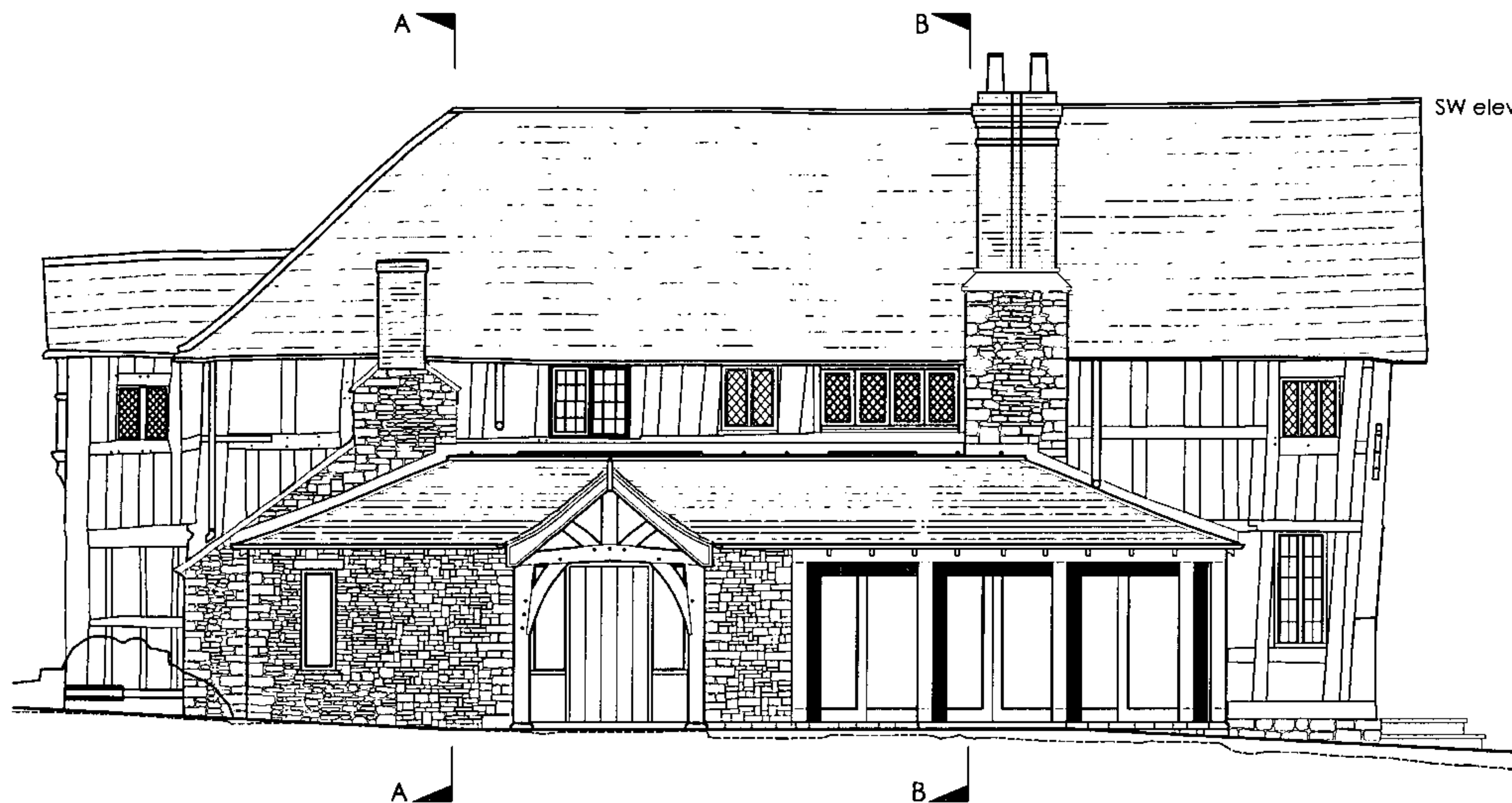
First Floor Plan of Manor House

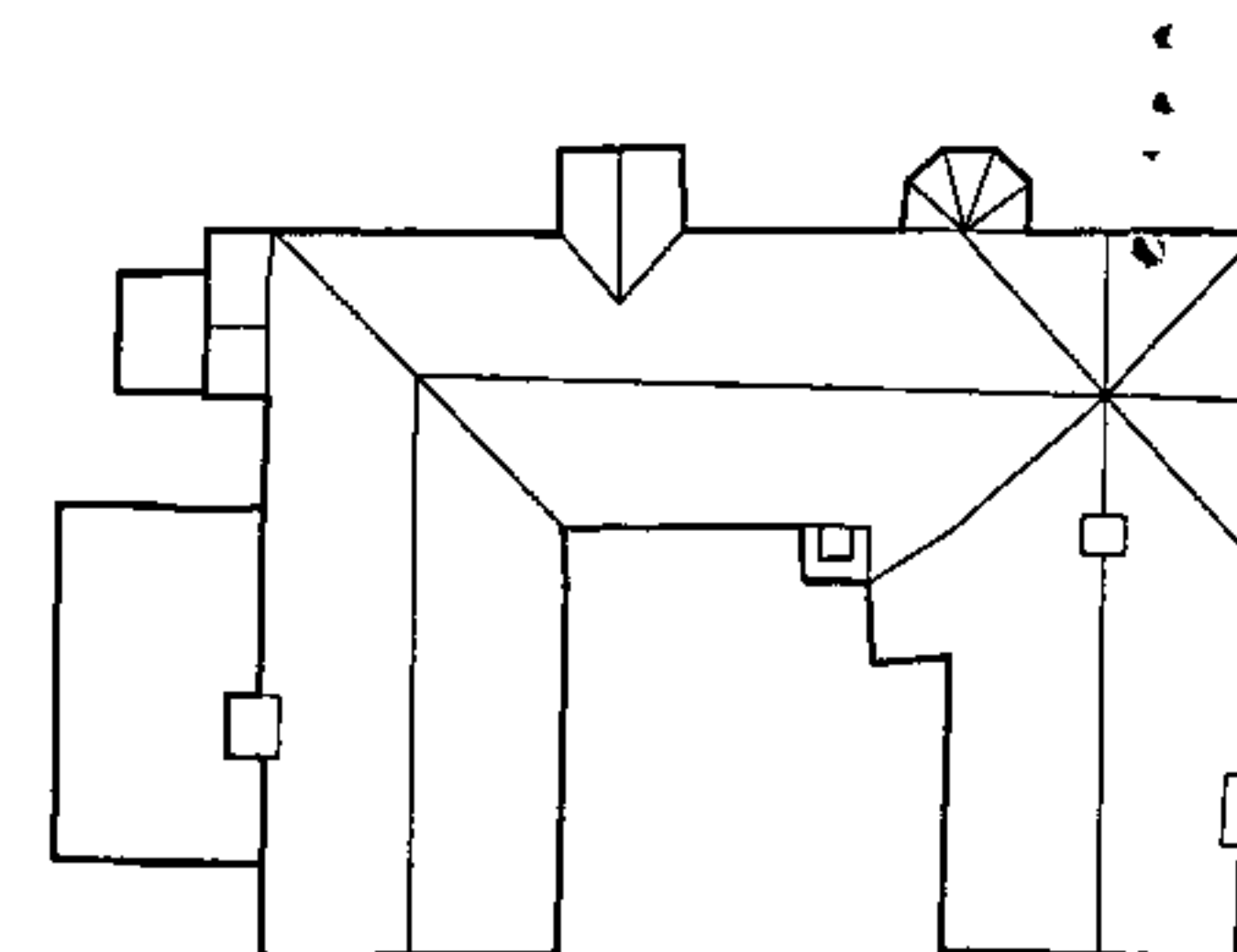

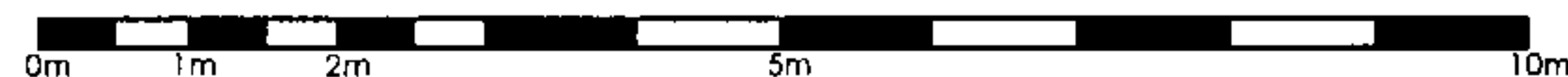

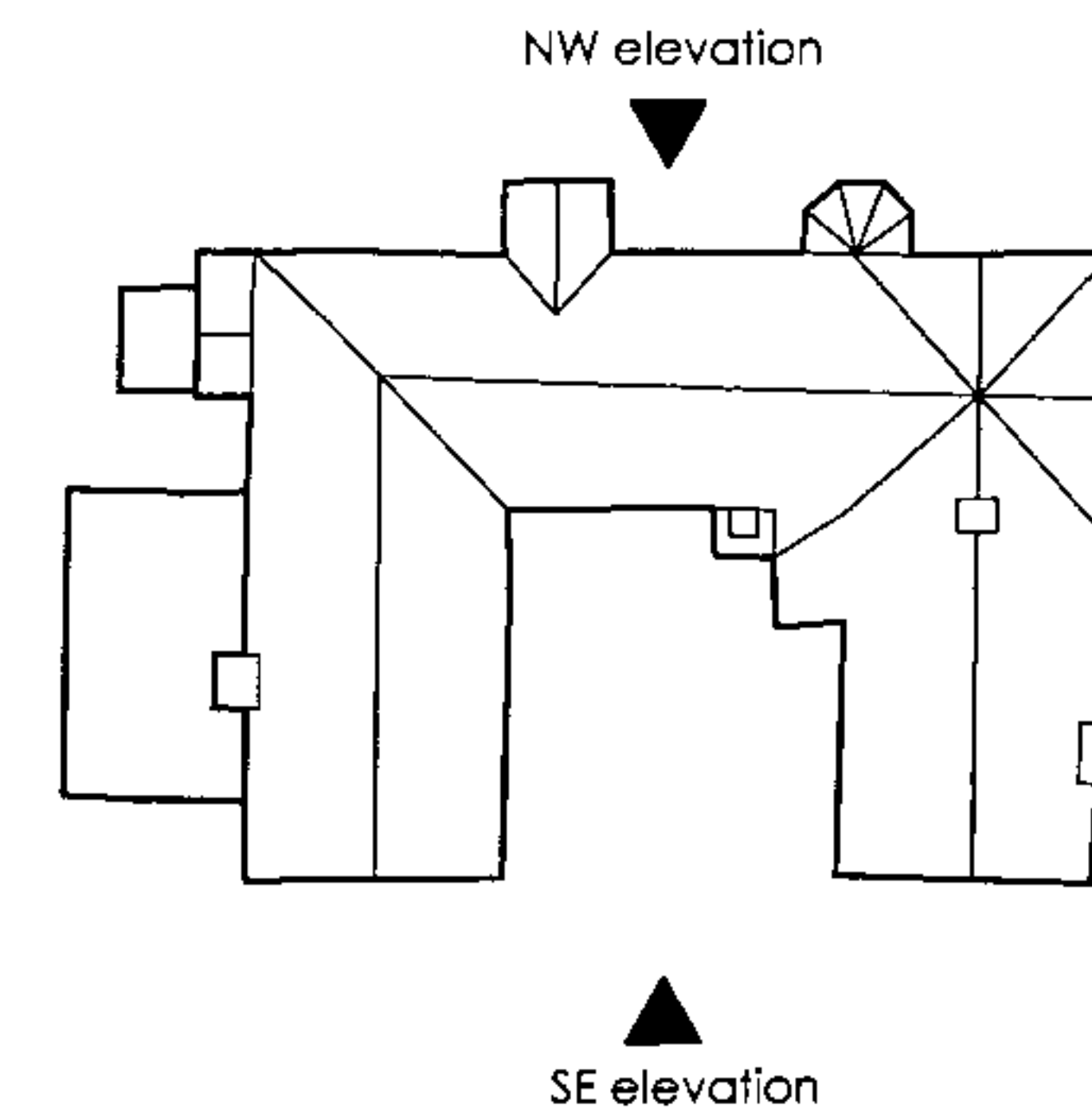
