Thank you for your email. When you refer to Veldifer being a substantial distance from the WRR corridor I assume you are referring to the illustrative Hereford Key Diagram at p. 53 of the draft Local Plan – Core Strategy?

If so, be aware that this does not chime entirely with the Amey Design Detail Booklet (Aug 2010) in which the outer corridor extends to encompass the Veldifer site. I have managed to speak to the Planning Policy Manager and he says unequivocally that the Amey defined corridors must take precedence and this accords with the Counsel's opinion that the Council has obtained; much of which was relayed to you in my letter from November in relation to Kings Acre Halt (142985/O).

You are correct that the Council is able to determine the application, but in the light of the above I have to state that this is likely to be a recommendation for refusal, which would then necessitate an appeal were your client so inclined. I see little merit in this approach. I would therefore recommend that in light of positive negotiations in relation to your actual proposal that have taken place hitherto, you agree an extension of time to allow the EIP to take its course, with the outcome hopefully shedding a measure of light on the route corridor options. You may otherwise consider withdrawing the application. Again, this advice is consistent with that we have received from Counsel.

I would therefore be grateful if you could clarify which of the three options outlined above you would wish to take at the earliest opportunity.
