Oak (T1)
Reduce large limb extending over roof and chimney by approximately 4 metres to a suitable live point to reduce leverage and risk of collapse. One low branch extending south over top of Elderberry, remove smaller branch growing over roof of building and reduce remaining section by approximately 3 metres to reduce leverage and risk of collapse. Medium sized low branch extending west over front of property, remove back to the main trunk. Large branch above branch being removed growing west, reduce in length by 4 metres to a suitable live point. Lift canopy on neighbouring property to a height of approximately 7 metres. Trim low branch encroaching on chimney of bungalow. Remove major deadwood.
Reason: Reduce risk of branch loss over property.
