1. Introduction

- 1.1 This application is for Prior Approval for the erection of a non livestock general purpose farm building. A further application has been submitted under a planning application for a further building (Building B an improved access and associated works) for livestock housing and which is within 400 m of protected property.
- 1.2 J Jones and Sons were until recently tenants with the Herefordshire County Farms. However with the sale of the County's Farms they were given a compulsory notice to quit and lost their holding, which was the base for their business. J Jones and Sons were dairy farmers but since losing their holding they have continued with their owned and share farmed land with a beef enterprise.
- 1.3 The applicants currently own the application site a 17.4 ha field and share farm a further 35 ha in the locality. They currently have some 120 beef cattle which were housed over winter in rented farm buildings until such time they are able erect their own farm buildings at the application site.
- 1.4 The building proposed is 30 m x 15 m building of general purpose design set some 10 m apart from proposed Building B. The building is 4.4 m to the eaves and 6.6 m to the ridge.
- 1.5 The applicant's DEFRA holding number is 17/96/24 and the site is in flood zone 1 i.e. lowest risk.
- 1.6 So far as we can ascertain there are no air strips in the locality and the building is more than 25 m from the C1099.
- 1.7 The GPDO now allows up to 1000 m² of farm buildings under the GPDO. The proposed building has a floor area of 450 m².
- 1.8 The applicant have no farm buildings of their own and the proposed building is reasonably required to store the feed, hay, machinery and equipment.
