T1 is a large multi-stemmed Leylandii standing to the south-western corner of the Royal Hotel. Applicant would like to cut back from the roof of property as the tree is starting to interfere with the building and is preventing TV reception. I have proposed that a middle stem (approx 8 inch stem) is removed entirely as it is causing the main issues. Removal of the stem will remove all branches interfering with the roof and TV areal and will also lift lower branches from in front of property windows, while still retaining a good shape.
