Thin groups of multi-stemmed Willow along river bank at Long Acre, particularly opposite benches to allow vista to river, removing most vulnerable stems liable to collapse. Approximate areas marked on 11836b - plan 1

Carry out remedial works to riverbank at Rope Walk meadow to allow vistas from seating area, removing badly collapsing stems. Approximate areas marked on 11836b - Plan2.

NOTE: It is essential that the Tree Officer meets Adrian Hope or a councillor at the site so proposal can be fully explained.
