I, Meirion Rhys Evans of Mobile Home at Ladybank, Credenhill, Hereford, HR4 7DN DO SINCERELY AND SOLEMNLY DECLARE as follows:

1. My name is Meirion Rhys Evans and since 1 March 2017 I have occupied the mobile home at Ladybank Farm, Credenhill, Hereford, HR4 7DN.
2. During the period of my occupancy of Ladybank Farm the farm has been run as a livestock farm rearing goats and sheep under a Farm Business Tenancy.
3. The purpose of this statutory declaration is to confirm that the occupation of the mobile home situated at Ladybank Farm (now known as Long Friday Farm), Credenhill, Hereford, HR4 7DN ("the Mobile Home") is ongoing.
4. The Mobile Home is situated in the location shown outlined red on the plan attached at **Exhibit A**.
5. I moved into the Mobile Home on 1 March 2017 and I occupy it as my sole residence. Council tax is payable in respect of the Mobile Home as evidenced by the attached bills for years 2016/2017 and 2017/2018 attached at **Exhibit B**.
6. The Mobile Home is self-contained and connected to both electricity and water and refuse is collected by Herefordshire Council as part of their normal weekly collection route.
7. The facts and matters set out in this statement are within my own knowledge unless otherwise stated, and I believe them to be true. Where I refer to documentation and facts and matters derived from other sources, these are to the best of my knowledge and belief.
