



Hi Lawrence,

It was good to speak with you yesterday about Eign Gate and the progression of the 4th Floor planning application. As discussed, I have put together 2 new sheets, which better illustrate the impact of the new Fourth Floor than the flat elevations alone. There are a couple of points that I would like to make clear:

1, The position of the windows on the Fourth Floor elevation will not read through to those on the floors below because of the set back of this floor from the edge of the

building. That said, there is some symmetry in the elevation and this has been highlighted on the new sheets.

2, The setting back of the plan form will create a natural variance in tone and form that will create more interest in the elevation than is seen through the flat elevation, this is better observed in the 3d visuals.

3, A slightly darker shade of colour and more matt finish to the Fourth Floor would create a more recessive appearance and this should be considered.

4, A Fourth Floor will create additional mass and this is not something that can be avoided. However, the impact of this additional mass has been lessened through the careful recessing of the additional structure.

In addition to the 3d visuals added to the new sheets, there are some additional images, which I have attached for your use. Some have not been selected, simply because the model is not up to date with the latest plan changes.

BTW, Matthew has used an old iteration of the elevations.

Please do get back to me with any queries. I look forward to hearing from you.
