The technical specification for the Log Yards boiler states the fuels as Wood - Chips – Peat. It is therefore unlikely whether wood or pellets would effect the emission rates.

With regard PM₁₀ emissions there is a lot less available information.

I have found the Sommerauer Eco Premium 250KW boiler (a similar size) that has measured PM_{10} emissions of 7.7g/GJ net heat output, which is significantly lower than 30 g/GJ.

Not to worry, thank you for checking

I have used Defra's Biomass Emissions Screening Tool (Version 7) to estimate if the biomass boiler emissions are likely to exceed the annual mean NO₂ AQS objective or not.

Information and methodology used

- From the information you have provided, I have found the following technical specification <u>Fabbri Termomeccanica s.r.l.</u>
 - From this I have taken the flue height (1.2m) and flue width (0.2m) and estimated the height of the building (7m).
- I have then taken the annual mean background NO₂ concentration from Receptor 3 (1 Crest Court) of the Air Quality ES Chapter estimated 2019 concentration (inclusive of roadside contribution) 11.1µg/m³.
- I have taken the NO_X emissions (143 mg/m³) from a slightly larger 250kw biomass boiler. See link to tech spec here: SMART 250 kW Smart Heating Technology
- I have converted the NO_X emissions (143 mg/m³) to get an estimated emission rate of 0.016318272 g/s.

Results

- The emission rate of 0.016318272 g/s is significantly below the emission rate target of 0.0739 g/s.
- In accordance with Defra's Biomass Emissions Screening Tool (Version 7), as the maximum stack emission rate is less than the target then it is not likely that the annual mean objective for NO₂ will be exceeded.

Is the above assessment sufficient to show the biomass boiler at the log yard will not have an impact on future residential users of the Proposed Development?
