Areas where omitted should be identified by planning and require expert assessment.

Areas include

Contamination and or depletion of boreholes used by local houses for drinking water. And provision for heavy rainfall.

Waste disposal, specifically chicken manure. How much, how often. And where disposed of. Presumably being transported along narrow lanes to local fields.

We also need a far more in depth appraisal of size, quantity and detailed frequency of all service traffic. In order to accurately assess the short and long term impact.

Other objections may include more detail. However you do not have enough information to safely and responsibly grant this application and should refuse it.

Provision for heavy rainfall – especially now climate change indicates more frequent and more severe events.

Waste disposal (specifically chicken manure). How, how much, how often and where disposed. The 'where' and 'how' presumably being transported along narrow local lanes to local fields. I have to presume this as I'm not told in the Application.

We also need a far more in-depth appraisal of size, quantity and detailed frequency of all service traffic in order to more accurately assess the short and long-term impacts. [REDACTED]
