T1 and T2 are common lime to around 13m in height standing adjacent to the B4234. T3 is a common lime of similar size standing just inside the grounds further back from the road than Ts 1& 2. All have been crown reduced in the past and have significant 3-4m re-growth as well as various cavities associated with heavy pruning this species. All have significant Mistletoe growth in the canopy which adds to the weight and sail of the limbs. Applicant would like to crown reduce all three specimens to around the previous pruning points in the interest of managing them safely when taking into consideration the strength of this species and the proximity to nearby road and footpath. A tree report was undertaken in 2015 which suggested the above action should be taken within three years.
