Further to below, I called the office yesterday morning to clarify.

The tracking is for two different sizes of refuse vehicle. Although only one vehicle size movement is given for the access, we can confirm that all movements including the access point works for both the medium and large refuse vehicles.

Your other comments refer to the road surface and construction specification rather than layout, so we feel this is a detailed design issue rather than a planning matter and would therefore be dealt with during the detailed design stage. I can however confirm that the detailed design parameters will include your requirements.

Hi Roland,

Apologies for not replying sooner.

The maximum carrying distance is 25metres – however I do have concerns regarding the surface of the driveway to plots 17&18. If this is to be gravel or grass then the collection point would need to be closer to where the vehicle can access.

Also, the road surfaces that the vehicle is expected to travel must be suitable for a vehicle weighing 26tonnes – so up to adoptable standards. Will this be the case?

There appears to be two different vehicle dimensions used in the tracking.
